Protecting the Enhancing the Environment

Created an Agave plantation with over 25,000 Augustiflora Agave plants. Built a nursery plantation for the growth of fruit, chitepin, ornamental and medicinal plants seeds for the local community. Plants grown in nursery are used for reforestation purposes. Bat and bird species are actively monitored and education is provided to the local community to protect the natural habitat for native species.



Local Exploratory Studies

- Itzkeni Civil Association conducted bat studies including migration and relationship to exploration activities
- Program focused on initiatives to protect the species which involved setting up nets and mist nets to identify the bat species and the population

Clean and Safe Water

Donated two geomembrane water basins totaling 100,000 liters of capacity for the storage of potable water for community households.

Performed annual monitoring of ground and surface water to ensure clean and safe water for the community.



Community Green Zone

Reinforced local dams to ensure consistent water supply. Financed creation of firebreak gaps and deadwood cleanup programs to limit forest fires. Built a Green Zone within community lands to facilitate a common green space.

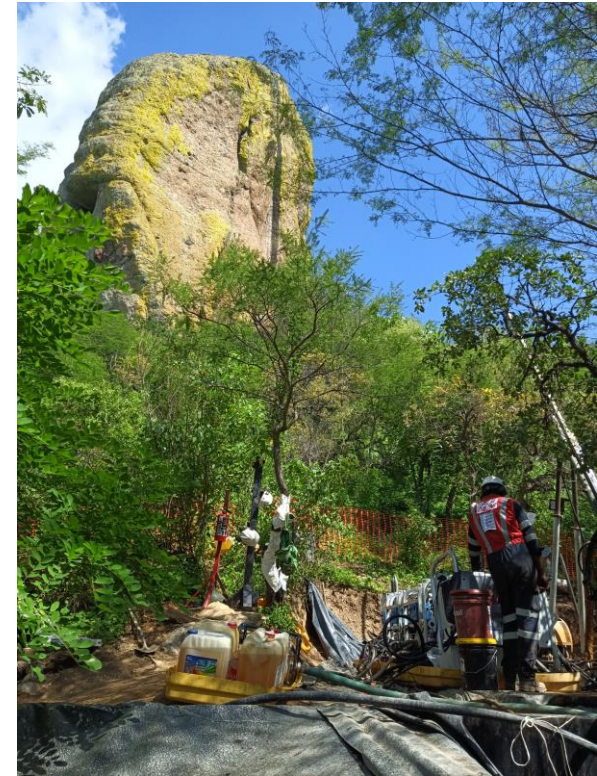


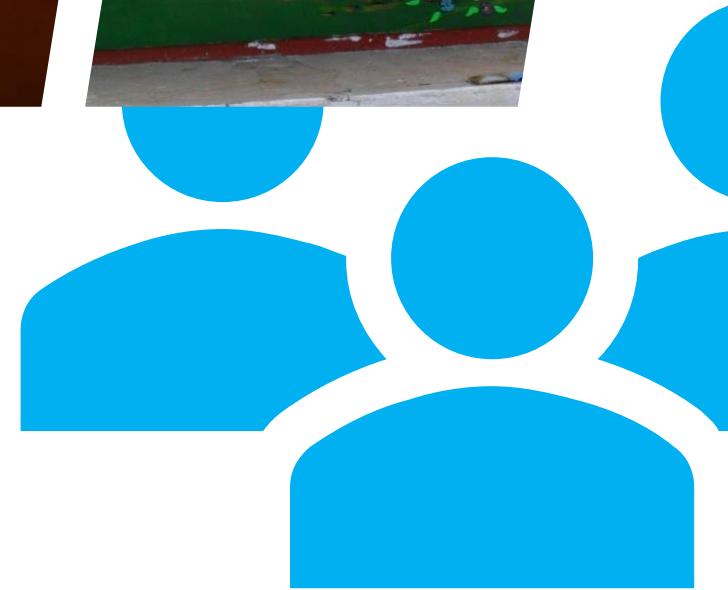
Technology Minimizes Environmental Footprint

Actively employ man-portable modular drill rigs that significantly reduce the environmental footprint of exploration

Drill occupies a maximum 4 m by 4 m space

No need to cut down trees or damage local flora as the drills can be positioned around them

Local Employment

Employment Opportunities. Appointed a committee of local women to manage the plant nurseries and generate income from selling the plants. Donated and installed a 40,000 liter geo-membrane basin, structure, shade netting, irrigation system, and equipment.

Hiring Local. Local hiring provides the opportunity for the community to grow, improve their skill set, generate income and creates a local mining work force.



Investing in Local Employment

Hired over 25 geologically qualified individuals such as Mexican geologists and prospectors to assist with its exploration and drill programs. Over a dozen labourers have been hired from the local communities.

Provides opportunity to the local members to acquire experience in the mining industry and expand their skillset as the Alamos project advances through the exploration cycle.

Protecting the Community from COVID-19

Employing system of protocols approved by the Mexican federal, state, and local health authorities which include

- Minimizing physical contact and ensure the health and safety of its employees, contractors, families, and local communities
- Continuous education on hygiene and sanitation

Initiatives include providing:

- Food packages to local ejido communities containing a quantity of staples such as beans, rice, masa, fruits and vegetables
- Hygiene supplies such as soap, hand sanitizer, face masks, antibacterial gels, liquid soap, mats, medicines
- Free monthly tests to the community, 545 tests performed to date
- Transportation and registration to get the vaccine

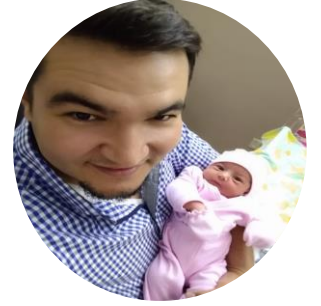
Socially Integrated Community

Microloan Program. In 2018, developed and funded a Micro-loan program with \$25,000 via 150 loans. The loan committee is constituted by members of the Union of Workers of the General Industry and Commerce of Sonora State. The program provides immediate financial support for business ventures and the financing of other items such as emergency medical bills, debt issues, vehicle repairs, household maintenance expenses, and educational tuition fees.

Community Cleanup. Organized a regular community cleanup for local members to come together and clean up garbage on roads, trails, school facilities and more. Donated garbage and recycling disposal cans within community to encourage proper disposal locations and prevent garbage buildup within the communal common grounds.

Elderly Support. Provide monthly financial income support for numerous elderly community members.

Sports. Donated soccer uniforms and equipment for the public safety department and youth members.



Infrastructure Development

Investment in Infrastructure. Fourteen security metal gates with locks were donated and installed at strategic locations to improve safety and control access to protected areas. A significant number of roads were repaired and new ones constructed increasing safety and connecting communities. Built and repaired cabins and public bathrooms to improve living conditions and accessibility. Funded a city welcome sign 'La Aduana' to increase visibility and tourism to the region, designed by community artists.

Conducted workshops/courses/lectures such as first aid training.
